I hereby specifically forever waive and release Boulder Creek, Equestrian Center, LLC, JRS Ventures Group, LLC, Boulder Creek Stables, LLC, Boulder Creek Farms, LLC, hereinafter referred to as, Boulder Creek Equestrian Center, and all principals and agents from any liability for injury arising out of the inherent risks from riding, working or participating in a stable environment and/or with horses, as well as from the active negligence of Boulder Creek Equestrian Center, and their principals and agents.
